The Nicholas Center: Nurturing Literacy Skills and Community Partnerships

Since its inception in 2012, The Nicholas Center at Hill-Murray has been a stronghold of support, creating transformative opportunities for students with learning differences and their families.

The Nicholas Center has a mission to empower neurodiverse student to use their God-given strengths to reach their fullest potential and become influential leaders shaping a positive world.







This mission has attracted Sara Johnson, Director of Literacy, and 19 exceptional teachers and tutors committed to the success of the students accessing The Nicholas Center.

These passionate educators use the Orton-Gillingham method, a science-based reading method known for its explicit, structured, systematic, and highly effective approach. Through The Nicholas Center at Hill-Murray, Sara and her team provide students with the tools and space to cultivate long-lasting literacy skills.

In partnership with Youth Advantage of Stillwater, The Nicholas Center hosts a 6-week summer reading program. Tailored for struggling readers entering 1st-6th grades, this program uses evidence-based reading approaches, grounded in the Science of Reading, to enhance crucial literacy skills such as phonemic and phonological awareness, vocabulary development, and reading comprehension. The success of the Summer Reading Program is evident in its growth, with approximately 75 students in 2023, and projections reaching 120 students in 2024.



Jim's remarkable career journey exemplifies unparalleled versatility and unyielding perseverance. His extensive leadership experience spans across a multitude of brands and industries, including Sims Sports, O'Brien International, The Coleman Company, The Pillsbury Company, U.S. Bancorp Piper Jaffray Seattle Investment Banking, and Northwest Bank Minneapolis (now Wells Fargo).

In 2001, Jim joined Brooks Running as CEO and is credited for the company's aggressive turnaround story. Under his stewardship, Brooks evolved from being dead last in the athletic footwear industry to becoming a pioneering frontrunner in the category. The business caught the attention of Warren Buffett, who declared Brooks a standalone subsidiary company of Berkshire Hathaway Inc. in 2012. Jim's leadership propelled Brooks into a league of its own, changing the landscape of athletic footwear.





On September 16, 2023, the Hill-Murray Fathers Club opened the Foxhole Bingo Lounge below the Crooked Pint in Maplewood. The Foxhole Bingo Lounge's goal is to raise \$500,000 annually to support the Hill-Murray Foundation's efforts to improve the school, campus, buildings, and grounds as well as provide scholarships to ensure a Hill-Murray education is accessible to all families. Hill-Murray Foundation Board Members, Mark Lambert and Chuck Runyon said, "In an effort to minimize tuition increases for families, the opening of the Foxhole Bingo Lounge provides a path for alternative sources of revenue."

The Foxhole Bingo Lounge will also support other Catholic schools and charities in the East Metro. In partnership with the Pioneer Foundation for the Performing Arts, volunteers can work at the lounge and provide grants to organizations of their choosing. The Foxhole Bingo Lounge anticipates donating an additional \$500,000 to Catholic schools and charities in the East Metro.

Hill-Murray Legend Leaves a Lasting Legacy



STEVE & KAREN FRICKEY were formidable figures within the Hill-Murray community. For more than three decades, Steve taught science and physical education and coached football, track, and basketball. Karen was an educator in her own right, teaching kindergarten for 39 years in Oakdale. Their lifelong commitment to education lives on as their estate bequeaths one of the most substantial gifts in the history of the Hill-Murray Foundation—an enduring tribute to their passion for learning and the future of the school.

COACH FRICK

Steve, or Coach Frick as he was affectionately known, was a man who commanded respect. Mike Sonntag '91 said, "[Coach Frickey] was tough, but he was fair. If he was quick to point out a mistake, he was even quicker to pat you on the back for success."

Coach Frickey had many highlights during his tenure at Hill-Murray: state tournament appearances, conference titles, section titles, celebrating his 100th win as Head Football Coach in 1995, and being inducted into the Hill-Murray Hall of Fame in 2012.

Over the years, Steve coached hundreds of athletes, taught hundreds of students, and mentored many teachers and coaches. Fellow Hall of Fame inductee and former Head Football Coach Vince Conway '71 states, "Even though I only played one year of high school football, he gave me a chance to coach a game I loved and I will always be grateful to him for giving me that opportunity. I gained valuable experience during those years and I never would have been able to become Hill-Murray's Head [Football] Coach if it wasn't for Coach Frickey."



A School Where Masterpieces Are Created Pioneer Premier Auction





The 2023 Pioneer Premier Auction, held at Hill-Murray on Saturday, April 29, was an impactful night for our students and the Hill-Murray community, who generously helped raise \$1.2 million!

The program video at the event featured alumni Caitlin Cheeseboro, Hill-Murray Class of 2014. Caitlin shared her experience of receiving a life-changing email from Hill-Murray admissions with the question: Are you interested in attending Hill-Murray? The opportunity to be a Pioneer allowed Caitlin to flourish and set her on the path to being a student-athlete in college, a teacher in Los Angeles, and a student at Harvard Law School.

Caitlin said her wish is for everyone to have the choice, support, resources, and community to get where they want to be; Hill-Murray did that for her. The generous donors at the Pioneer Premier Auction make that possible for other students like Caitlin. Student enrollment at Hill-Murray is over 1,000 students for the first time in over 10 years due to the success of the Pioneer Premier Auction and the generosity of the Friends of Hill-Murray.

During the program, President Melissa Dan presented the 2023 President's Award to Mark and Irene Lambert, who have used their leadership skills to impact Hill-Murray School. Irene served as Chair of the Pioneer Premier Auction for two years and led the first event that raised more than \$1,000,000. Mark has served in leadership roles at Hill-Murray for the past 10 years. As the Hill-Murray Fathers Club President, Mark grew the annual contributions to the Hill-Murray Foundation from \$100,000 to \$400,000 through charitable gambling proceeds. Mark continues to make an impact as a member of the Hill-Murray Foundation Board. In this role, Mark has led initiatives to increase alternative revenue sources outside of tuition increases, resulting in the opening of the Foxhole Bingo Lounge in 2023. \$1.2 million raised!




